Public Hearing

Notice is hereby given that a Public Hearing on the proposed 2018 Budget will be held on Monday, November 13, 2017 @ 6:30 p.m. during the regularly scheduled meeting of the Chenequa Village Board at the Village Hall located at 31275 W County Road K, Chenequa, Wisconsin.

The budget is available for review at the administrative offices in the municipal building.

Tax Levy

Good News! Proposed 2018 tax levy is \$1,929,428 (a decrease of 6.5768% from last year) with a proposed tax rate of 4.09790568 per thousand (a decrease of 8.8% from last year).

Tax Collection

Tax bills will be mailed the last week of November/first week of December. First installments of tax payments may be made at the Village Hall during normal business hours. Tax payments can also be mailed to the Village Hall or placed in the drop box. Payments postmarked on or before December 31, 2017 will be receipted as a 2017 payment. Any payments found in the drop box at 8am on Monday morning, January 1st, will also be receipted as a 2017 payment.
