Village Board Approves Tax Levy

The Village Board has approved the 2017 Village Budget. Tax levy is set at \$2,065,256. The 2017 total assessed value for the Village of Chenequa set by the Assessor is: \$459,464,700, resulting in a tax rate of \$4.49 per thousand of assessed value.

Tax Collection

Tax bills will be mailed early-December. Tax payments may be made at the Village Hall during normal business hours, Monday through Thursday from 8:00 am to 4:30 pm and on Friday from 8:00 am to 3:00 pm. Tax payments can be mailed to the Village Hall or placed in the drop box at the main entrance. After processing payments, receipts will be mailed to you. Payments postmarked on or before December 31, 2016, will be receipted as a 2016 payment. Any payments found in the drop box at 8:00 am on Monday, January 2nd, 2017 will also be receipted as a 2016 payment.

If you are leaving town for more than a couple of days and would like the Police Department to make a periodic check of your home, please call the Village Hall or Police Department so we may fill out a House Check Report form for you. This form can be found online at <http://www.chenequa.org/eservices/requests> and can either be dropped off at the Police Department or emailed back to us at policeclerk@chenequa.org. Please make sure the form is filled out in its entirety. This will help our officers protect your home while you are away. If you return early, please call us so you are not surprised by a visit from an officer.

Dog Licenses

Soon it will be time to renew dog licenses for 2017. **Please remember that you must submit a copy of your dog's current rabies certificate along with your application.** We cannot issue a dog license until we have a copy of the rabies certificate in our office. A copy of the Application for Dog License is enclosed or one can be obtained at our website: <http://chenequa.org/eservices/dog-licenses/>. **It is Village Ordinance and State Law that all dogs be licensed,** and it also makes it easier to return lost dogs that are on record in Chenequa.

New Village Ordinance

8.23 LAND AND UNNECESSARY NOISE PROHIBITED

(8) OPERATION AND MAINTENANCE OF PERMANENT STANDBY GENERATORS

No person shall use, operate or maintain a permanent standby generator except during electrical outages and as required by the manufacturer for maintenance purposes. Maintenance operation shall only take place between the hours of 9:00am and 3:00pm, Monday through Thursday in accordance with manufacturer's specifications and not to exceed once a week.

Further revisions to come in December to allow for testing on Saturdays from 10:00am – 2:00pm.

Beware - Be Vigilant

The holidays are upon us and crime is always up this time of year. Chenequa Police Officers are here and ready to answer your call for service anytime day or night. Should you see a person or vehicle in an area they are not to be in or are not known to you, do not approach.

We need your eyes and ears as well as our patrols to keep the community safe; this is a partnership. If we work together and look out for each other, we will hopefully be able to continue to deter crime in the Village.

Bow Hunters

A reminder for those of you who have allowed bow hunters on your property: please complete the permission slip with the requested information and make sure the Chenequa Police Department has a copy on file. This is voluntary but we encourage you to assist us in identifying who is in the Village and has permission to be on properties. Please get full information before granting permission to anyone; check them out on the Wisconsin Circuit Court Access website <http://wcca.wicourts.gov/> to see if they have criminal history. If you decide to grant permission, please share the information with your Police Department so we know what vehicles and people are in the Village legitimately. Your cooperation in this is very important to our policing effort.



Police Department Personnel Changes

We are pleased to welcome a new full time police officer to our staff. Adam Skerbish has been hired on to fill a vacancy created by the retirement of Police Captain David Reid earlier this year. Officer Skerbish was with the City of Oconomowoc Police Department for 20 years. Officer Skerbish also served his country as a Marine before starting his law enforcement career.

Snow Plowing and Salting of Drives

Plowing of public and private roads is done as needed to ensure access for emergency vehicles and safe passage for other vehicles. Please have your 2017 plowing agreement and check to the Village Hall by December 30, 2016.

- The plowing and sanding of private driveways is a unique service that normally begins when a snowstorm subsides and there is *2-3 or more inches of snow*.
- Driveway plowing is systematically done to provide this service in an efficient and economical manner and it *takes between 6-12 hours to service the entire Village, depending on conditions*.
- Vehicles and other obstructions must be removed or a drive will be passed by until it is clear.

The Village will only salt hills, curves and intersections. We will not salt your circle drives, the area to your entry way, or around your garage doors. Anything flat is your responsibility as a homeowner. We had many calls last year from residents looking for salt on their entire drive or particular areas we were just unable to accommodate.

A fertilizer spreader or grass seed type of spreader with some calcium chloride or sidewalk salt, these can be purchased at any hardware store to handle those areas for you. We also urge you to be sure to place your driveway markers so the Village snowplow drivers know where to avoid.
