### **Public Notice**

Notice is hereby given that a Public Hearing on the proposed 2019 Budget will be held on Monday, November 12, 2018 @ 6:30 p.m. during the regularly scheduled meeting of the Chenequa Village Board at the Village Hall located at 31275 W County Road K, in the Village of Chenequa.

The budget is available for review at the Village Hall during business hours.

### **Tax Collection**

Tax bills will be mailed the last week of November/first week of December. Only the first installments of tax payments may be made at the Village Hall during normal business hours. Second installments of tax payments need to be sent to Waukesha County.

Tax payments can also be mailed to the Village Hall or placed in the drop box. Payments received on or before December 31, 2018 at noon will be accepted as a 2018 payment.

You may pay your bill online by credit/debit card or by electronic check using Point and Pay. There is a \$1.50 fee for electronic check (eCheck) and a \$10 fee associated for transactions greater than \$10,000.

## **VILLAGE OF CHENEQUA OFFICIAL NOTICE GENERAL ELECTION LOCATION, HOURS OF POLLING PLACE AND BOARD OF CANVASSERS**

The polls will be open for the General Election to be held on November 6, 2018, from 7:00 AM to 8:00 PM. Voting will take place at the Chenequa Village Hall located at 31275 W County Road K in the Village of Chenequa. Polling place is accessible to elderly and disabled voters.

At the close of Election Day, pursuant to the provisions of Wis. Stat. §19.84, the Election Inspectors will convene as a joint meeting of the Municipal Board of Canvassers for the purpose of conducting the municipal canvass pursuant to Wis. Stat. §§7.51 and 7.53(1). This meeting will be open to the public pursuant to Wis. Stat. §§19.81-89.

If needed, the Municipal Board of Canvassers will also hold a meeting at 4:00 p.m. in the Village Hall to process and count late-arriving provisional ballots (if any) that arrived in our office by mail on Friday, November 9, 2018.
