# VILLAGE NEWS

There will be a Public Hearing on May 8th at 6:30 pm

Ordinance to Amend Section 6.03(2), Create Section 6.05(3)(d), and Repeal Section 6.05(4)(b)(x)

The purpose of the public hearing is to accept public comment on the proposed amendments. The proposed amendments revise the definition of the term "Accessory Structure" to include structures which are a conditional use, designate a "Private Storage and Maintenance Facility" as a conditional use and repeal the minimum acreage requirement for conditional uses.

## FORESTRY NEWS

A reminder to all and especially our new residents, any cutting along the lakeshore requires a permit from the village. To protect the scenic beauty, control erosion, and reduce effluent and nutrient flow into the lakes.

Village Ordinance 6.09 regulates any cutting within 75 feet of the shore.

## HIGHWAY/ROAD NEWS

It is important to be mindful that the scenic and beautiful private drives are not only used to get you in and out of your home. In the event of an emergency, they will need to be spec'd large enough to support an emergency vehicle. This means that brush/ tree limbs must be cleared to allow for a 12'Wx12'H opening.

Additionally, keep in mind of your driveway's current condition. Driveways that are cracked or developing pot holes are extremely taxing on the village equipment and should be considered for repair or replacement.

#### Stay Alert to Phone Scams

"Say Yes" Scam - Scammers call and ask you a series of questions that lead you to respond with "yes," all the while recording. Scammers then use the recording of your "Yes" to authorize purchases from your bank account or other financial decisions. Watch out for any unsolicited call that starts with a question, such as "Hello, is this <u>(your name)</u>?" or "Can you hear me?" Take a couple of seconds to decide whether to hang up or to reply with something along the lines of "Who is calling?" Remember to stay on guard throughout any suspicious call.

Please be wary of anyone asking for any kind of personal identifiable information!
