VILLAGE OF CHENEQUA OFFICIAL NOTICE PARTISAN PRIMARY LOCATION, HOURS OF POLLING PLACE AND BOARD OF CANVASSERS

The polls will be open for the Spring Primary to be held on August 14, 2018, from 7:00 AM to 8:00 PM. Voting will take place at the Chenequa Village Hall located at 31275 W County Road K in the Village of Chenequa. Polling place is accessible to elderly and disabled voters.

At the close of Election Day, pursuant to the provisions of Wis. Stat. §19.84, the Election Inspectors will convene as a joint meeting of the Municipal Board of Canvassers for the purpose of conducting the municipal canvass pursuant to Wis. Stat. §§7.51 and 7.53(1). This meeting will be open to the public pursuant to Wis. Stat. §§19.81-89.

If needed, the Municipal Board of Canvassers will also hold a meeting at 4:00 p.m. in the Village Office to process and count latearriving provisional ballots (if any) that arrived in our office by mail on Friday, August 17, 2018.

Does Your Driveway Meet Emergency Standards?

2018 has been a prolific growing year for most of our trees and shrubbery. For some, this growth has resulted in driveways starting to "tunnel" in. In the event of an emergency, all driveways need to be large enough to support an emergency vehicle. This means that brush and tree limbs must be cleared to allow for a 12'Wx12'H opening. Failure to do this can result in slower response times and damaged emergency equipment.

Additionally, please be mindful of your driveways current condition. Driveways that are cracked or developing pot holes are extremely taxing on the village plow equipment and should be considered for repair or replacement.
