A RESOLUTION FOR BUDGET ADOPTION AND TAX LEVY

WHEREAS, the Board of Trustees is appropriating the necessary funds for the operation of the government and administration of the Village of Chenequa for the year 2020, and

WHEREAS, there is hereby appropriated out of the receipts of the Village of Chenequa for the year 2020, including monies received from the general property tax levy, to the various purposes specified in the budget publication notice attached as Exhibit "A", and

WHEREAS, the Village of Chenequa general property tax levy for 2020 has been increased by the general obligation debt service authorized by the Village of Chenequa in accordance with Wisconsin Statute §66.0602(3)(d)(2).

NOW, THEREFORE, BE IT RESOLVED, there is hereby levied the tax levy amount of \$1,966,767 on all the taxable property within the Village of Chenequa as returned by the assessor in the year 2019, for the uses and purposes set forth in the budget, and the total tax base for the Village of Chenequa in the year 2019 is \$495,429,300.

BE IT FURTHER RESOLVED, that the rate per thousand for the Village of Chenequa in 2019 based on the above numbers is \$3.96982374.

BE IT FURTHER RESOLVED, the Village Clerk/Treasurer is hereby authorized and directed to spread this tax on the current tax roll of the Village of Chenequa.
