Foresty Department and Driveway Clearance

With winter just around the corner, our Forestry department will likely be out plowing within the next few weeks. It is important to take a detailed look at your driveway and surrounding vegetation to ensure our plow vehicles will be able to adequately serve you. Ordinance 5.23 (Driveway Regulations) requires that foliage must be a minimum of 2′ outside the driveway edges with a minimum height of 10′ to overhanging foliage. Failure to clear and trim this brush will directly result in damage to emergency response vehicles and plow trucks. If your driveway is not passable with our large equipment, snow plowing services may be temporarily suspended.

Additionally, please remember to install plow markers to delineate the edges of your driveway. Not marking your driveway makes it extremely difficult to locate the driveway boundaries and often results in landscape damage. The Village of Chenequa may not plow your driveway if it is not properly marked.

Tax Levy Update

The proposed 2021 tax levy is \$1,938,890 with a proposed tax rate of 3.81609144 per thousand (a tax rate decrease of .153%).

Tax Collection

Tax bills will be mailed between the last week of November and the first week of December. Only the first installment of tax payments may be made at the Village Hall during normal business hours.

Second installments should be sent to the Waukesha County Treasurer at the County's address, which you can find on your tax bill. Payments received on or before December 31, 2020 at noon will be receipted as a 2020 payment.

You may pay your bill online by credit/debit card or by electronic check using Point and Pay. There is a \$1.50 fee for electronic check (eCheck) and a \$10 fee associated for transactions greater than \$10,000.
