As a result of the snow we encountered in January, you may have damaged trees or brush. Just a reminder, as always, no cutting of trees, brush, or any vegetation is allowed within 75' of a waterway in the Village without a permit. The purpose of this is to prevent erosion, filter runoff before it goes to the water, maintain a healthy aquatic ecosystem, and preserve the natural beauty of all the shorelines.

You need education if you are at least 12 years old, were born on or after January 1, 1989, and will be operating a motorboat or PWC in Wisconsin.
