Animal Regulations

Village Ordinance 8.16 states that is shall be unlawful for any owner to have an animal which:

- Assaults or attacks any person or animal.
- Acts in such a manner as to justify the belief that it is vicious or dangerous. A showing that an animal has bitten, attached or injured any person, animal or property shall constitute prima facie showing that such animal is vicious or dangerous.
- Annoys or disturbs persons living in the area by howling, whining, yelping, barking, meowing or otherwise making noise which causes serious disturbance to persons living in the area.
- Runs *At Large off an owner's premises.
- Because of its aggressive nature, training, or characteristic behavior, is capable of inflicting serious physical harm or death to humans or animals and which would constitute a danger to human life or property.

*At Large: At Large shall include all places except the owner's premises. The term includes streets or other public and private property which may abut or be in the vicinity of an owner's premises. An animal shall not be considered to be running at large if it is on a leash or other device and under the control of a person of suitable age physically able to control it.

Reminder for Everyone

With all the construction going on during the warmer months, it's important to remember that the Village does have an ordinance (5.25) on PERMISSIBLE TIME FOR CONSTRUCTION ACTIVITIES.

Memorial Day through Labor Day

Monday through Friday: 7:00 a.m. to 6:00 p.m. Saturday: 9:00 a.m. to 3:00 p.m.

After Labor Day and Before Memorial Day

Monday through Friday: 7:00 a.m. to 6:00 p.m. Saturday: 9:00 a.m. to 6:00 p.m.

<u>Sunday and Federal or State Holidays</u> No such work is permitted.

Pine Lake Weed Treatment

The treatment of Pine Lake for Eurasian Milfoil control is scheduled for Wednesday, June 12, 2024 (Weather Permitting). The chemicals will not be applied if the applicators feel conditions are unsafe, such as storms, heavy rain or high winds. We have allowed Thursday, June 13th as a rain date. The recommended precautions after treatment are as follows:

- NO swimming for 1 day
- NO garden watering for 21 days



Refuse and Recycling Collection – Yard Waste Disposal

We recently learned that Johns Disposal offers yard waste disposal to the Village of Chenequa residents.

The yard waste can be dumped at their Whitewater facility. They have a yard waste dumpster at the front of their building located at 105 County Road U, Whitewater, WI 53190.

Hours are: Monday through Friday 8am - 4:30pm.

The drop off is closed on weekends and holidays but is open seasonally from spring through fall. They usually end the season at the first snowfall.

Yard waste should be "pure" with NO plastic, wire or twine/ tap. Compostable paper bags ARE accepted. Compostable plastic bags are NOT accepted by Johns because they are not accepted at compost sites.

Trailer loads are NOT accepted and contractors are NOT to dump at their facility.
