## Boating Reminders



**Reminder for everyone:** all powered boats operating on any public waterway in the State of Wisconsin must have a Wisconsin Certificate of Number (registration) and expiration decals to operate a recreational vessel legally. The Certificate of Number (registration card) must be on board and available for inspection by an enforcement officer whenever the vessel is operated.

The registration number and expiration decals must be displayed as follows:

- Numbers must be placed on each side of the forward half of the vessel.
- Number must be read from left to right.
- Number must be at least 3” high BLOCK letters.
- Numbers must contrast with the color of the vessel and be clearly visible and legible.
- Letters must be separated from the numbers by a space at least two inches wide.
- Decals must be affixed three inches behind (toward the stern) and in line with the number.
- Two-tones and camouflage numbers are not legal and should not be used.

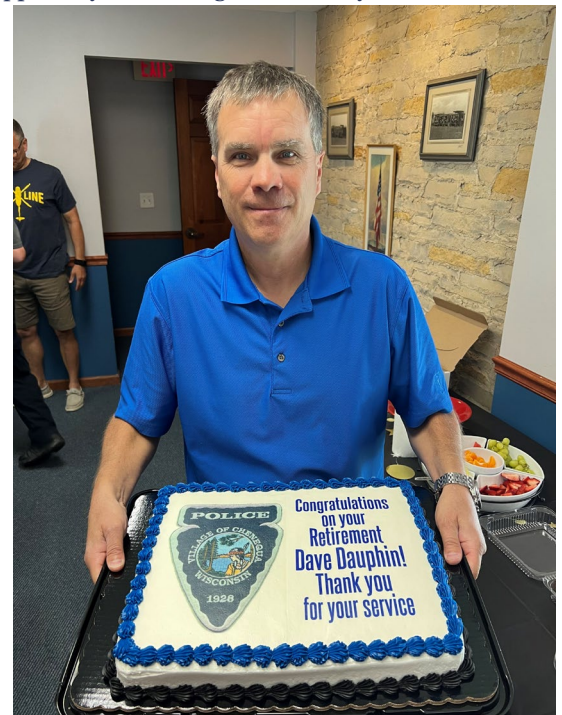

## Outdoor Burning Regulations

**Prior Approval is Required.** All persons shall obtain authorization from the Police Department before kindling or maintaining any fire. (262) 367-2145 or after hours, non-emergency number (262) 446-5070.

All open burning bonfires and recreational fires shall be constantly attended and supervised by a competent person at least (16) years of age until such fire is extinguished. This person shall have fire extinguishing equipment available and shall be responsible for properly and thoroughly extinguishing all open burning, bonfires or recreational fires before leaving the fire unattended.

Burning is prohibited when the wind velocity is predicted to exceed (9) miles per hour or local circumstances make the fire potentially hazardous. For more information on burning ordinances please visit: [Outdoor Burning Regulations](#)
